**OFFICIAL RULES**

**HOW TO PARTICIPATE**

1. Promotion is valid at Virgin River Casino & Lodge and CasaBlanca Resort & Casino only.
2. Participants must be at least twenty-one (21) years of age and be a Mesquite Journey Rewards Club member to participate.
  - a. Rewards Card Membership is free and available at the Players Club at both Virgin River Casino & Lodge and CasaBlanca Resort & Casino.
3. The \$10,000 Jackpot Drawings promotional period is April 1 – 30, 2025.
4. Participants can earn entries into the Jackpot Drawings by hitting a taxable jackpot valued at one thousand two hundred dollars (\$1,200.00) or higher.

8. It is the player's responsibility to deposit their drawing tickets into the drawing drums prior to the drawings at each property.
  - a. Drawing drums are located at the Mesquite Journey Rewards Club at each property.

**DRAWING DETAILS**

1. Drawings will be held on Wednesday, April 30, 2025, at both Virgin River Casino & Lodge and CasaBlanca Resort & Casino.
  - a. The drawing at Virgin River Casino & Lodge will be held at 6:00 p.m. on Wednesday, April 30, 2025.
  - b. The drawing at CasaBlanca Resort & Casino will be held at 7:00 p.m. on Wednesday, April 30, 2025.

2. At each drawing, a total of five (5) winners will be drawn from the drawing drum to qualify to win prizes.
3. Only one (1) winner will be selected at a time.
  - a. Winners will have three (3) minutes to claim their prize.
4. Winners must present a valid photo I.D. and their Mesquite Journey Rewards Card when claiming their prize.
  - a. Winners who do not claim their prize within three (3) minutes with an authorized promotional representative will forfeit their prize.
  - b. Redraws will commence every three (3) minutes until a valid winner is present.
